Ran and set Baker Model D 2" x 5 1/2" x 17# production packer at 9,672'. Ran 2-3/8" O.D. 4.70# J-55 8rd thd. E.U.F. tubing with Baker seal assembly, Fluid Pack casing pump, filter assembly, sand strainer and circulating valve. Bottom of tubing at 9,681.38'. Started well to pumping August 30, 1965.

Instructions
