**7" to be set at approx. 9650' w/sufficient cement to obtain 1000' of fill.**

**All casing will be set and cemented in accordance with approved methods.**

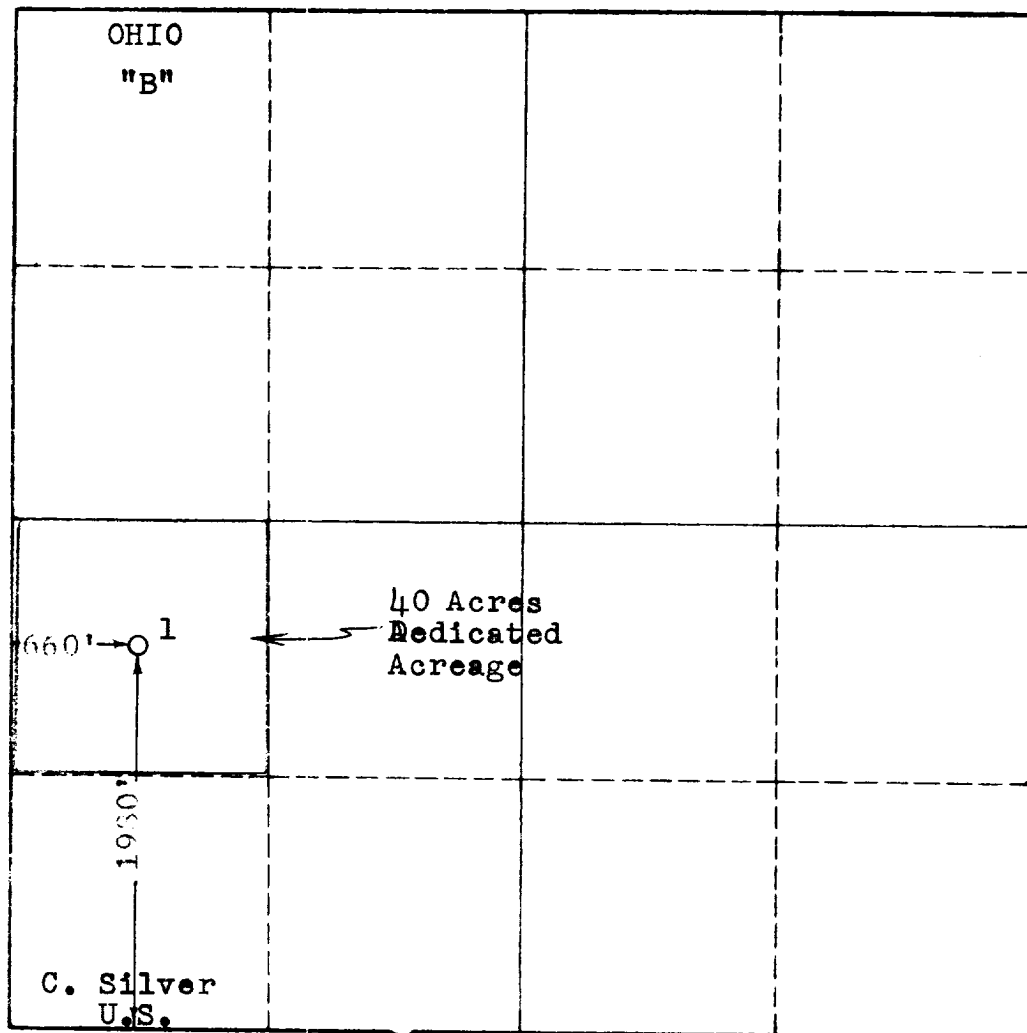
