We propose to drill Shell Date-Federal Well No. 1 as a 5750-foot Pennsylvanian test w/Rotary Tools as follows:

Drill 17 1/2" hole to 300', cement 48#, 13 3/8" casing w/400 sx. Circulate cement.

Drill 11" hole to 4120', cement 32#, 3 5/8" casing w/500 sx. Circulate cement.

Drill 7 7/8" hole to 5750', cement 11.6#, 4 1/2" casing w/300 sx.
