1. RIH w/2-3/8" tbg to sand fill @ 9575'. (Bad casing 4300-5510'). Displace hole w/9.5# mud. Spot 150' cmt plug (20 sx) from 9575-9425'. Pull tbg to 8000'. Wait on cmt 4 hrs & tag plug.
2. Spot 150' cmt plug (20 sx) from 7750-7600'.
3. Spot 150' cmt plug (20 sx) from 5500-5350'. Pull tbg to 4000'. Wait on cmt 4 hrs & tag plug.
4. Spot 100' cmt plug (10 sx) from 4200-4100'.
5. Cut 5-1/2" casing @ 2600'. Displace hole w/9.5# mud. RIH w/2-3/8" tbg & spot 100' cmt plug (20 sx) from 2650-2550'. (50' in & 50' out of 5-1/2" casing stub).
6. Spot 100' cmt plug (25 sx) from 450-350'.
7. Spot 50' surface plug (15 sx).
8. Cut off wellhead 3' below Ground Level. Install Dry Hole Marker.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
