DETAILS OF WORK



1. Set 8 5/8" 24# casing @ 350' and cure cement. Pressure test casing to 1000 psi for 30 minutes.
2. Set 4 1/2" casing 9.5# @ 4700'. Cement w/200 sx cement. Pressure test casing to 1000 psi for 30 minutes.
3. Perforate San Andres and sand oil frac w/20,000 gals refined oil and sand in 4 stages using rubber balls.
4. Run tubing and put well on production.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

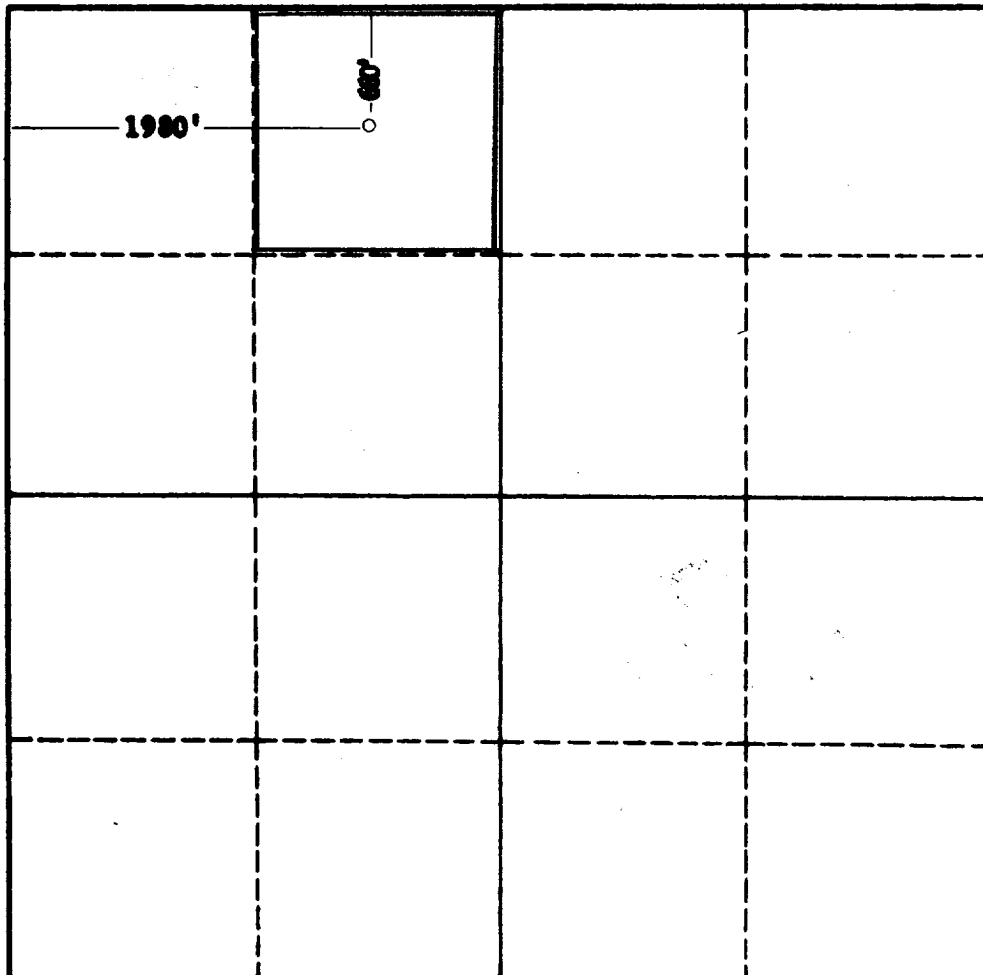
