Instructions

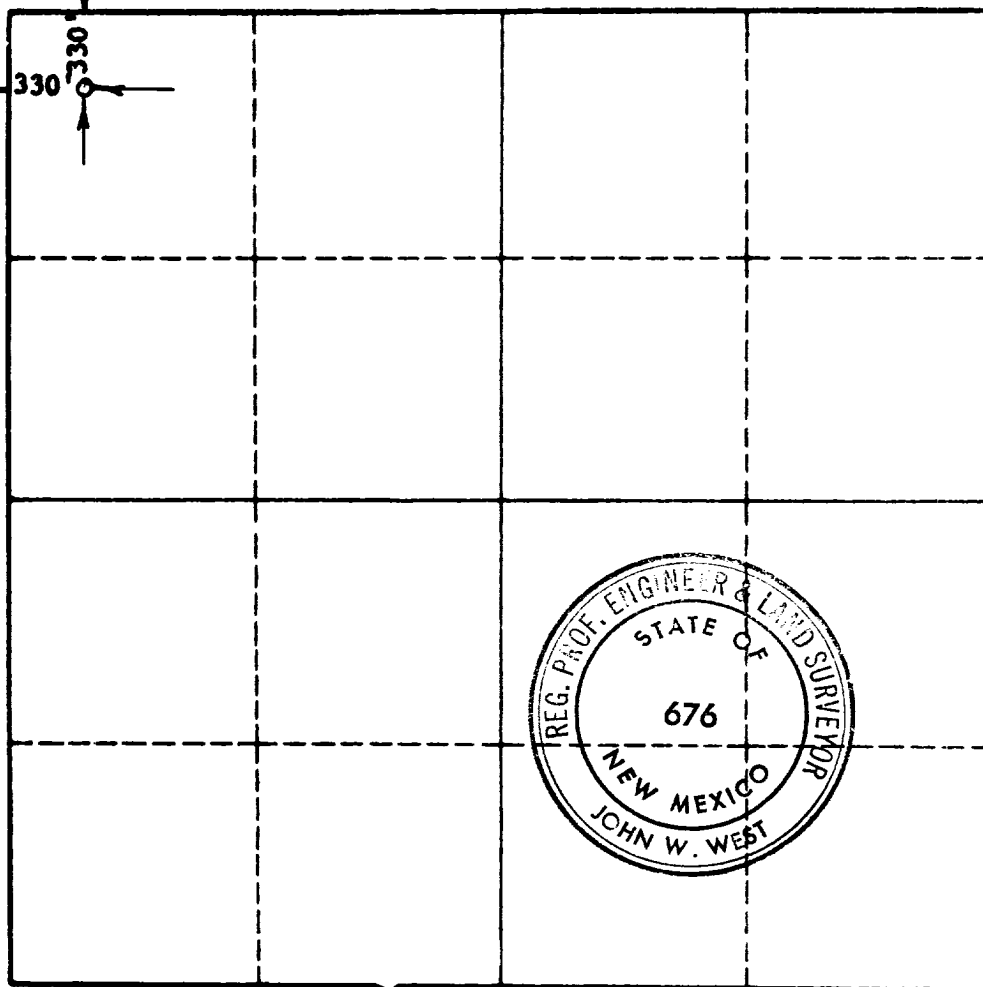
