11/28/64 - Ran new 4-1/2", 9.5#, J-55 casing liner with a TIW liner hanger and packer from 3930-4977'; cemented with 170 sacks 1-1 Pesmix Incer with 2% Gel. W. O. C. 24 hours.
11/29/64 - Tested @ 3500# pressure for 30 minutes - test O. K.
11/30/64 - Ran Gamma Ray log and perforated 4750-4755' with 2 shots per foot. Clean-out total depth was 4967'.
12/1/64 - Ran RTTS Packer and acidized with 500 gal. 15% NE. Started swabbing.
12/2/64 - Swabbed total of 20 hours - results, 10 barrels of sulphur water per hour.

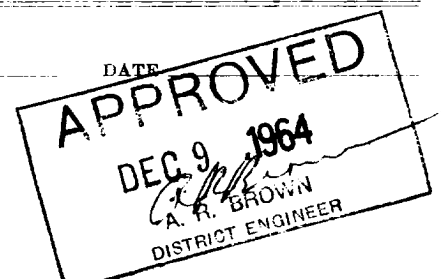

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
