AIR 20 BPM at 2700-2900#. Well would not flow after extensive snubbing and pumping equipment was installed. All oil load (780 barrels) was recovered by 3-29-65 but a gel block condition was treated on 1-18-65 with 500 gallons paraffin solvent in 3000 gallons kerosene, treated on 2-12-65 with 2000 gallons 5% acid and treated with 1000 gallons mud acid on 3-2-65 to relieve gel block. On 24 hour test ending 10 AM, 3-30-65, pumped 6 barrels of oil and 19 barrels of water, OOR TSTM, 12 x 34" BPM.
