Ran 153 joints 4 1/2" OD 9.50# J-55 ST & C casing. Set and cemented at 4803' with 350 sacks 16% gel, 2% salt and 2/10% HR7 retarder, followed by 180 sacks neat cement around bottom. Plug down at 7:15 AM, 11-16-64. MP 1100#.

Waited on cement for 14 hours, tested 4 1/2" OD casing with 1000# for 30 minutes; no drop.

Instructions

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
