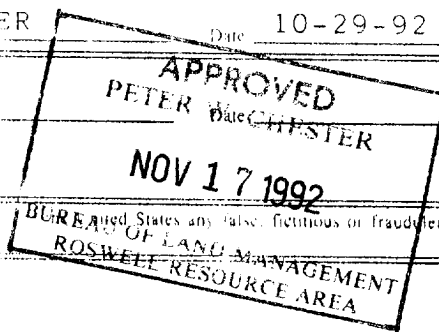

Additional Stipulations for Casing Integrity Test

1. The cast iron bridge plug shall be set within 100 ft. of the upper most perforations or casing shoe if completed open hole.
2. Also notify the New Mexico Oil Conservation Division (NMOCD) prior to test.
