On November 4, 1963 a retrievable bridge plug was set at 4230' above perforations at 4202' to 4276' in the Todd Lower San Andres B zone. The Todd Upper San Andres or A zone was perforated one shot per foot at the following places: 4141', 4143', 4148', 4166', 4179', 4187', 4202', 4206', and 4208'. A packer on 2" tubing was set at 4110' and well acidized with 7500 gallons DS-30 acid. Well potentialed flowing 1.25 MCF per day. This form filed pursuant to conversation with Mr. Nutter and Mr. Runyan with the Oil Conservation Commission January 9, 1967. We assumed this form had been filed by the original operator.

Instructions

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
