On 2-26-64, 4-1/2" OD 9.5# J-55 casing was set at 4689' with 200 ex liner nest.

Tested casing with 1200 PSI for 30 minutes. Test OK. Perforated 4625-36, 4645-50, 4662-76 W/2 SPT. Acidised with 500 gallons and fraced with 10,000 gallons oil and 11,100# Sand. Cleaned out to 4684'. Swabbed in and evaluated.

On FT well flowed 75 BO X O BW 24 hours thru 22/64" choke. TPF 100, CPF 100, GOR 956, CGR 30°.

Instructions
