Cactus Drilling Co. spudded 11" hole at 6:00 PM on 3-26-64. On 3-27-64, 8-5/8" OD 2 1/2" J-55 casing was run and set at 397' with 200 sz. Cement circulated. After WOC 18 hours tested casing with 1500 PSI. Test OK. Reduced hole to 7-7/8" at 397' and resumed drilling operations.
