Moved in service unit 7-12-80. Ran tubing and packer and set at 4600'. Acidized with 4000 gallons 15% NEFE acid in 2 stages separated by 200# rock salt and 200# paraformaldehyde. Flush with 12 bbls. fresh water. Swabbed well. Pulled packer and ran pumping equipment. Returned well to production. Production after workover in 24 hrs. was 1 BO and 67 BW.
