Propose to plug and abandon the wellbore per the following:
Move in service unit. RIH with 2-3/8" workstring open ended and tag fill at $\pm 4040'$. Spot 100 sx of class C neat cement for 4040' to 2403' in 3-7/8" open hole. Pull tubing and WOC. RIH with cement retainer for 4-1/2" casing. Set retainer at 2350'. Squeeze parted interval with 500 sx of class C neat cement. When a 1000 psi squeeze is obtained, sting out of retainer and pull up and dump excess cement. Displace casing with 10# brine with 25#/bbl of salt gel and POH. RIH with 3-1/8" casing gun and perf 4-1/2" casing at $\pm 460'$ with DPJSPF. RIH with packer and tubing. Set packer at $\pm 100'$ and pump brine water down tubing to establish circulation between 4-1/2" casing and 8-5/8" casing. After circulation is established, pump 150 sx of class C neat cement down tubing and up between 4-1/2" X 8-5/8" casing strings. When circulation is established, displace cement 200' below packer with brine water. Close bradenhead and pressure up to 500 psi. Shut in over night and WOC. Release packer, drop down, and displace casing with 10# brine water with 25#/bbl of salt gel. POH. Spot 10 sx of cement at surface. Rig down and move out service unit. Erect permanent abandonment marker and weld on cap.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
