Cactus Drilling Co. spudded 12-1/4" hole at 1:45 PM on 10-29-64. At 7:15 PM, 8-5/8" OD 24# J-55 casing was set at 412' with 225 ax. Cement circulated. After 100 hours, tested casing with 1500 psi for 30 minutes. Test OK.

Reduced hole to 7-7/8" at 412' and resumed drilling operations.

Instructions
