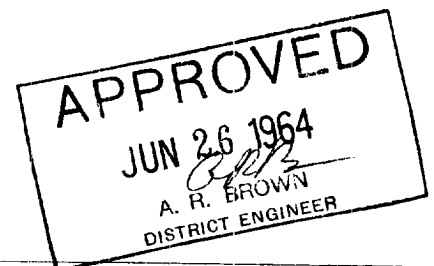

On 6-7-64 4-1/2" OD 9.5# J-55 casing was run and set at (TD) 4686' with 200 mx. Tested casing with 1200 PSI for 30 minutes. Test OK. Drilled out to TD 4685'. Perforated 4656'-74' w/2 SPV

Acidised with 900 gal. Fraced with 20,000 gal oil, 13,000# sand, 2,000# glass beads.

Swabbed in and evaluated.

On test, well pumped 98 BO X 4 bbls acid water in 24 hours. GOR 575, GGR 30°
