Well spudded July 28, 1965. Set 11 jts. (362') of new 8-5/8" OD 2 1/2" 8-2 SS 3-55 R-2 KMC casing at 376' and cemented with 250 sacks of cement by the Pump & Plug Process. Cement circulated to surface. Plug down at 8:30 A.M., July 28, 1965. W.O.C. 2 1/2 hrs. Pressured up to 600# for 30 mins. and casing tested OK. Drilled out cement plug and pressured up to 1000# for 30 mins. and casing shut off tested OK.
