It is our intention to dispose of produced salt water into the San Andres formation of this well with injection into an open-hole interval from approximately 4315' to 4340'. The well will be deepened from the present T.D. of 4315' to 4340'. Two-inch plastic-lined tubing will be installed in a packer set at approximately 4300'. The casing-tubing annulus will be filled with an inert fluid and a pressure gauge will be attached to the annulus at the surface to determine that there is no leakage in the casing, tubing or packer. Utilization of this well as a salt water disposal well has been previously approved by the Oil Conservation Commission of New Mexico, Order No. R-3619. We request your approval of the conversion of this well to a salt water disposal well.

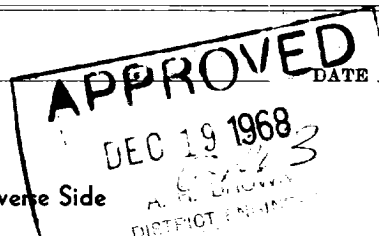

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
