2. Set 4 1/2" C.I. Bridge plug @ 4100' capped with 40' of cement.
3. Cut and remove 4 1/2" casing.
4. Set 100' cement plug 50' in and 50' out of 4 1/2" stub.
5. Set 100' cement plug 2050' to 1950'
6. Set 100' cement plug 400' to 300'
7. Set 10' cement plug in top of surface casing.
8. Install regulation marker
9. Clean location.
