Reached total depth of 4430' on October 5, 1965. Set 140 jts (4419') of new 4-1/2" OD 10.5# GR SS J-55 RT & C casing at 4428' and cemented with 350 sacks of cement by the pump and plug process. Plug down at 8:45 p.m., October 6, 1965. WOC 24 hrs. Temperature survey indicated cement outside of 4-1/2" OD casing at 3534' from surface. Did not drill out cement plug.
