Spudded well on October 26, 1965. Set 11 Jts. (390') of new 4-5/8" OD 24# GR 35 J-55 RT & C casing at 370'. Cemented with 250 sacks of cement by the pump & plug process. Plug down at 5:30 p.m. October 26, 1965, and cement circulated to surface. WOC 24 hrs. Pressured casing up to 1000 lbs for 30 minutes and casing test OK. Drilled out plug at 375'. Pressured up to 600 lbs and casing shutoff tested OK.
