1. Spot a 100' plug to cover all perforations.
2. Load hole w/mud-laden fluids.
3. Pull approximately 3,000' of production casing.
4. Spot a 100' plug across casing stub.
5. Spot a 100' plug in and out of the base of surface casing.
6. Spot a 10 sx plug in top of hole and erect a 4" regulation marker.

AMENDMENT:

Cement plug over perforations should be a minimum of 25 sacks.
Place additional 100' cement plug in interval 1700-1800 feet.
