Reached total depth of 4500' on March 11, 1966. Set 141 jts (4488') of new 4-1/2" OD 10.5# SE SS 4-55 RT & C casing at 4500'. Cemented with 350 sacks of cement by the pump & plug process. Plug down at 12:00 Midnight March 12, 1966. Temperature survey indicated cement outside of 4-1/2" OD casing at 3187' from the surface. W.O.C. 24 hrs. Pressured up to 600# for 30 minutes and casing tested OK. Did not drill out cement plug. P.B.T.D. 4458'.
