Reached total depth of 4500' on April 5, 1966. Set 145 jts. (4488') of new 4-1/2" OD 10.5# 8-R 88 J-55 R-2 RT&C casing at 4500' and cemented with 390 sacks by the Pump and Plug Process. Plug down at 11:15 A.M. April 6, 1966. Temperature Survey indicated top of cement behind 4-1/2" OD casing 3022' from surface. W.O.G. 24 hrs. Pressured up to 600# for 30 mins. and casing tested OK. Did not drill out cement plug at 4499'. P.B.T.D. 4499'.
