Cactus Drilling Co., spudded 11" hole 4-17-66. On 8 5/8" OD 24" J-55 casing was set at 450' and cemented with 250 sq. Incon meat. Cement circulated. After M.O.C. 18 hours, tested casing w/ 1000 psi for 30 minutes. Test O.K.

Reduced hole to  $7\frac{7}{8}$ " at 450' and resumed drilling operations.
