17. Describe Proposed or Completed Operations (Clearly state all pertinent details, and give pertinent dates, including estimated date of starting any proposed work) SEE RULE 1903.

In accordance with verbal authority from Mr. Eric Englebrecht, work of plugging and abandoning referenced well started 21 March, 1967, and was completed 22 March, 1967. Plugging was performed in the following manner:

A 45 sx cement plug was set from 4215' (PBTD) to 3730'. Cut-off was made at 1800'. A 35 sx cement plug was set from 1850' to 1725'. A 35 sx cement plug was set from 385' to 285', in and out of surface casing set at 361'. A 10 sx cement plug was set from 30' to surface. All intervals between cement plugs was filled with mud. A well marker has been placed at the location for identification. Surface area is benig cleared of all equipment and the well location returned to natural contour. The location should be ready for inspection within 90 days from date.
