Drill 12-1/4" hole with to 400'. Set 8-5/8" OD 24# casing and cement to surface. Then drill 7-7/8" hole to 4500' and set 5-1/2" OD 14# casing and cement with 350 sacks of cement. Run logs and complete in the San Andres. Will install 8" Shaffer, Type 45 BOP's with pipe rams in top and blind rams in bottom. Casinghead outlets will be used for kill and choke lines.
