Well uneconomical to produce. Proposed plugging procedure:

1. Pump LCM pill to TD/perfs and follow with 25 sx cement, tag; circulate w/gelled brine.
2. Cut casing at free point, set 100' plug; tag; circulate gel.
3. Set 100' cement plug at base of 8-5/8" shoe.
4. Set 10 sx cement plug at surface; install P&A marker.
