Plugging procedure

1. Hole loaded with mud.
2. Spot cement plugs down tubing using Lea County Casing Pullers pump as follows:
 - a. Spot 25 sacks at 4403 feet.
(Shot pipe off at 2977 feet - pulled pipe out)
 - b. Spot 25 sacks at 2400 feet.
 - c. Spot 25 sacks at 425 feet.
3. Place 10 sacks in top of hole and install permanent marker.
4. Cleaned up location.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
