

Reached total depth of 4478' on November 9, 1966. Set 138 Jts. (4467') of new 4-1/2"OD 10.5# 8R SS J-55 R-2 ST&C casing at 4478'. Cemented with 400 sacks of cement by the pump and plug process. Plug down at 6:15 P.M. November 10, 1966. Temperature survey indicated cement outside 4-1/2"OD casing at 3379' from the surface. WOC 24 hours. Pressured casing up to 600# for 30 minutes and casing tested okay. Did not drill out cement plug. P.B.T.D. 4452'.
