10-15-87: Set CIBP @ 4200'. Spot 3 sxs cement on top of plug. Load hole with mud. Cut off and pull  $\pm$  2000' of 4 1/2" production casing string. Spot 45 sxs cement plug across surface casing shoe 460' to 360'. Tag plug and load hole with mud. Spot 10 sxs cement plug at surface and erect dry hole marker.
