Moved in Cactus Drilling Company rotary tools. Spudded well @ 11:30 A.M. 10/14/67. Drilled 12-1/4" hole to 377'. Ran 12 jts 8-5/8" OD 8R 24# J-55 casing w/float collar & guide shoe = 360.40'. Set @ 372.65'. Cemented w/250 sx Incor cement containing 2% CaCl. Plug down @ 6:00 PM 10/14/67. Cement circulated. After 20-1/2 hrs WOC ran 7-7/8" bit. Tested 8-5/8" casing to 1000# for 30 min. Held OK. Resumed drilling.
