Spudded 12 1/4" hole 1:30PM 4/22/68. Cemented 8 5/8" 24# H-40 Casing at 333' with 225 sacks type "H" Longhorn Portland cement 2% Calcium Chloride. Cement circulated. Dumped plug with 300# 6:30PM 4/22/68. WOC 18 hours and tested casing with 1100# for 30 minutes, test O.K.

Cemented 4 1/2" 9.5# & 11.6# J-55 casing at 4498' with 300 sacks Halliburton light cement and 350 sacks Inco Permox, 6% gel, 0.75% CFR-2, 11# salt per sack. Dumped plug with 1400# 11:40 AM 5/1/68. WOC 48 hours and tested casing with 2000# for 30 minutes, test O.K.
