June 8, 1968: Ran 57 jts of 7", 23# casing set @ 1820 feet rotary table measurements. Cement w/250 sks, 8% gel and 150 sks 2% CC. Plug down 1:30 p.m., 6-8-68. Cmt circ to surface. Tested casing w/1000 psi for 30 mins - held o.k. WOC.

Resumed drilling operations June 10, 1968. Now drilling ahead.
