On 11-6-69, NUPU, ran Guiberson Type AF pkr on 139 jts of 2-3/8" EUE, 8RT, plastic coated thg and set at 4350' w/ 12,000# tension. Loaded annulus with inhibited fresh water, installed pressure gage on csg. opening. Rigged down. On 11-18-69, hooked well to disposal system and started water to formation thru perfs @ 4408-10' & 4413-15'. Well took 180 BW on vacuum overnight.
