Spudded 17-1/2" hole 9-11-69 at 11:30 A.M. Cemented 12-3/4" casing at 417' with 375 sacks regular. Cement circulated. Plug down 9:15 A.M. on 9-12-69. W.O.C. 24 hours and pressure tested casing with 600# for 30 minutes. Test O.K. Cemented 8-5/8" casing 24# & 32# at 4000' with 400 sacks. Plug down 9:15 A.M. on 9-17-69. W.O.C. 24 hours and pressure tested casing with 1000# for 30 minutes. Test O.K. Cemented 4-1/2" 11.6# casing at 9835' with 450 sacks. Plug down 4:15 A.M. on 10-12-69. W.O.C. 48 hours and pressure tested casing with 2000# for 30 minutes. Test O.K. Top cement behind casing by temperature survey 8100'. Perforated 9745-58' with 5 holes. Acidize with 2000 gallons 15% mud acid.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
