2. Cut off 4-1/2" casing and spotted 25-sack cement plug at 6841'. Recovered 6841' of 4-1/2" casing. (3018' left in hole)
3. Spotted 25-sack cement plug at 8-5/8" casing shoe at 4000'.
4. 8-5/8" casing pulled apart at 310'. Spotted 50-sack cement plug at 380'. Recovered 310' of 8-5/8" casing. (3690' left in hole)
5. Spotted 10-sack cement plug at surface with marker.
6. Hole was loaded with mud laden fluid.
7. Plugging operations completed 11-12-71.

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
