2. Propose to set bridge plug at 7000' with 20' of cement on top. (Perfs. 9783-94)
3. Propose to spot 25-sack cement plug at 4-1/2" casing stub at approximately 5000'.
4. Propose to spot 25-sack cement plug at 8-5/8" casing shoe at 4000'.
5. Propose to spot 25-sack cement plug at 8-5/8" casing stub at approximately 1200'.
6. Propose to spot 25-sack cement plug at 12-3/4" casing shoe at 400'.
7. Propose to spot 10-sack cement plug at surface with marker.
8. Hole will be loaded with mud laden fluid.
9. Tentative date of plugging operations is 10-1-71.

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
