- 10-27-69: After WOC 18 hrs., pressure tested casing to 600 psi - O.K. Now drilling ahead.
- 10-30-69: Drilled 11" hole to 3940'. Ran 8 5/8" O.D. 32# J-55 casing set @ 3940' w/2000 sx cement. Circ. to surface. Plug down 6:45 p.m. 10-30-69. WOC.
- 10-31-69: After WOC 18 hrs., tested casing to 1000# for 30 min. - O.K. Now drilling ahead.
