The subject well was temporarily abandoned April 22, 1970 after unsuccessfully testing the San Andres. The well has 5½" casing set at 4788' and no mechanical problems have been observed. We propose to leave the well in its present temporarily abandoned status and are now exploring the feasibility of a flood of the San Andres on our Baetz Federal lease immediately to the east of the Kirkpatrick #7. If a flood is feasible we plan to use the Kirkpatrick #7 as an injection well.

Instructions
