Drilled 3-3/4" hole to 7693'. Ran tubing w/packer and set at 7500'. Acidized open hole 7638-93' w/500 gals 15% HCl, swab.

Acidized open hole 7638-93' w/3000 gals 20% HCl, swab.

Set cement retainer at 7630'. Squeezed open hole 7638-93' w/100 ex Class C cement. Complete at 4:30 PM 1-1-72. Reverse out 5 ex cement. PRTB 7630'.

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
