Pumping equipment has been installed on the Federal "E" #1. The prime mover for the pumping equipment is an Ajax 8 1/2" x 10" gas engine and has been equipped with an exhaust muffler. The subject well is located in the habitat of the Lesser Prairie Chicken. In accordance with the operating rules of the BLM as applicable to operations in the habitat of the Lesser Prairie Chicken, the "noise" created by the gas engine was measured 03/03/03 with a db meter. The "noise" recorded was predominately at the 60 db level with momentary spikes to 74 db, which is within the guidelines set out by the BLM. The measurements were taken 30 ft. from the source and in all directions from the source. Mr. J.R. Hogwood, BLM-Roswell, witnessed the noise measurements.
