Drilled to a total depth of 4800'. On 12-24-83, ran 5-1/2" 15.5# K-55 and J-55 casing. The casing was set at 4800'. Cemented casing with 500 sx class C lite containing 15# sx salt and 5# sx gilsonite, 850 sx class C lite containing 15# sx salt, and 475 sx class C neat cement. Circulated out 12 sx of cement. Displaced cement with 24 bbl brine water. Brine water froze and after thawing could not move cement. WOC 18 hrs. Ran 4-3/4" bit and drilled out plug and cement from 1310'-4737'. Drilled float collar and cement to 4775'. Rig released 8:30 pm 12-28-83. No further report until move in completion unit.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
