The subject well was spud 12-15-83 with a 12-1/4" bit. Drilled to a total depth of 400'. On 12-16-83, ran 8 5/8" 24# K-55 casing and set at 400'. Cemented casing with 250 sx class C cement with 2% CaCl₂. Circulated out 25 sx of cement. WOC 18 hours. Pressure tested casing 1000 psi for 30 mins. Held OK. Reduce bit to 7 7/8" and resumed drilling.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
