Ran 82 jts 8-5/8" 24# & 32# J-55 ST&C casing set 3415'. 1-guide shoe set 3415'. Float collar set 3370'. Cemented w/900 sx Pacsetter Lite "C" w/5#/sx salt and 3% CaCl2. Tailed in w/250 sx Class "C" w/2% CaCl2. Compressive strength of cement - 1250 psi in 12 hrs. PD 5:30 PM 4-18-85. Bumped plug to 1250#, released pressure, held okay. Cement circulated 42 sacks. WOC. Drilled out 8:00 PM 4-19-85. WOC 26-1/2 hrs. NU and tested to 1000# for 30 minutes, OK. Reduced hole to 7-7/8". Drilled plug and resumed drilling.
