Cemented w/ 300 sx Class "C" cement w/ 4% gel, 22 #/sx salt, 1/4 #/sx cellophane flakes. 17 1/2" Hole @ 13.6 ppg. Yield 1.71 ft³/sx; followed w/ 200 sx Class "C" cement w/ 2% CaCl₂ @ 14.8 ppg. Yield 1.32 ft³/sx. Circ 115 sx cement to surface. Made cut off.
- 07-15-88 - Ran 91 jts, 8 5/8", 32#/ft, J-55, ST&C Intermediate Casing w/ 6 centralizers. Set @ 3810'. Cemented w/ 1500 sx 65/35 % Class "C"/Poz w/ 15#/sx salt, 1/4 #/sx cello-flakes. 12 1/2" Hole @ 12.8 ppg. Yield 1.98 ft³/sx; followed w/ 300 sx Class "C" @ 14.8 ppg. Yield 1.32 ft³/sx. Displaced w/ 231 bbls fresh water. Bumped plug w/ 300#. Plug down @ 1830 hrs CDT. Circulate 390 sx cement to surface. Made cut off.
- 08-05-88 - Ran 100 jts, 5 1/2" 17#/ft, N-80 LT&C Production Casing and 129 jts, 5 1/2", 17#/ft, K-55, LT&C Production Casing. Landed casing shoe @ 9198'. Cemented w/ 700 sx 65/35 % Class "H"/Poz w/ 6% gel, 5 #/sx salt @ 12.75 ppg. Yield 1.91 ft³/sx; tail-in w/ 430 sx Class "H" w/ .5% fluid loss additive and 2% defoamer and retarder @ 15.6 ppg. Yield 1.18 ft³/sx. Displaced w/ 210 bbls 2% KCL water. Bumped plug w/ 800# over final pressure. Plug down @ 2:30 PM CDT. Made cut off. Ran temperature survey indicating TOC @ 5475'.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
