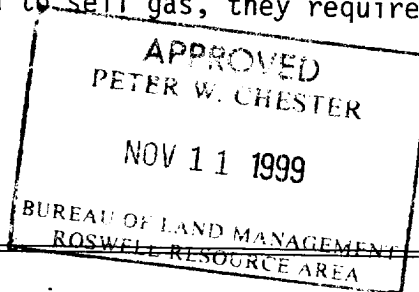

2. The meter station (meter run) belongs to Dynegy and the meter number (number of the measurement station) is 1754. *only well on meter*
3. The gas rate of the Appaloosa was not sufficient for Dynegy to economically lay a gas line to the lease site. If Manzano wanted to sell gas, they required that we lay the gas line to them.
