Paloma Resources, Inc. proposes to drill out the cement plugs currently in the Peery Fed #1 well. The cement plugs were placed in the wellbore when plugged. The 5 1/2" casing will be tied together at 7300' prior to proceeding deeper than 7300'. The casing will be cleaned out to 11,300' to test the Devonian Formation. Surface facilities, caliche pad, and road are still currently in place and have not been restored.

BOP Program: Double Ram BOP's will be used with a 5000# WP rating.

Mud Program: Brine water will be utilized during drilling out cement plugs.

All Casing and BOP's will be tested daily.

When completed as a producing well, all current flowlines and surface facilities on the lease will be utilized.
