C.I.P. @ 2:25 a.m. Filled around 8 5/8" casing w/3 yds. pea gravel to 12' from top. Cemented top of casing w/8 sx. reg cement. W.O.C. 18 hrs. Nipped up. Tested casing w/600 psi 30 min. ok.

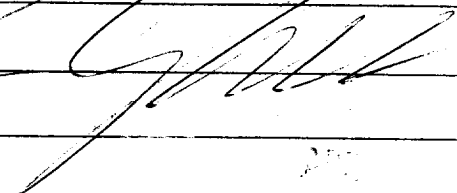
